Procurement Legal Surgery #5 - what will the PSR will mean for you?

Further to the introduction of the Provider Selection Regime (PSR) regulations into Parliament on 19 October 2023, subject to parliamentary scrutiny, DHSC intends for the PSR regulations to come into force on 1 January 2024. Our fifth Procurement Legal Surgery in partnership with Hempsons LLP will provide a briefing for NHS LPP members. Hempsons has been advising NHS England on the development and introduction of the PSR and this session will provide you with an explanation of the new law, and how it is likely to work in practice.
